### D020296-B-E HEPI Right Side Foundation Plate:

- 1. Relocated positions for upper ½-20 UNF thru holes at X-pos: from 1.446 in. to 1.360 in. and Y-pos: from 2.872 in. to 4.520 in.
- 2. Relocated positions for lower ½-20 UNF thru holes at Y-pos: from 9.557 in. to 8.703 in. No changes in X-positions.
